The Wip Excellence strategies have been developed and implemented with the aim of generating profits over the medium to long term. Although there have been periods in which they have been in drawdown, in the long run they have generated high returns with limited volatility, keeping actual market risk under control.

Wip Excellence 2 involves the use of two distinct strategies that have historically generated profits not correlated with those of traditional investments:

- a medium term option writing strategy that involves the use of options on Deutsche Borse Dax index, Eurex Bund future and Cme EuroFx future. The method used is quantitative, statistical and 100% systematic. The investment objective is to create profits in up or down markets while maintaining very low correlation with traditional asset classes.
- a long-term strategy that uses a technical/quantitative Trend Following approach. The performance achieved so far ranks near the top of the class, as it has regularly beaten the CSFB Tremont Hedge Fund Index and the CSFB Tremont Hedge Managed Futures Index. The strategy involves the use of the world's most liquid futures on bonds, stock indexes and currencies: Australian Dollar, British Pound, Canadian Dollar, EurUsd, Japanese Yen, Eurodollar interest rates, German Bund and Dax. Therefore, the risk associated with illiquid investments is greatly reduced.

The methodology does not attempt to predict the trend of the market, rather the objective is to follow the trend of prices once these have been identified by proprietary algorithms. When this happens, the system sends out the trading signals. The exact application of these signals, without the subjective interpretation and analysis of the markets, is the most important aspect of the investment process.
